3.1 The City may immediately terminate this License with forfeiture by the Licensee of all License Fees paid to the City if:

- a) the Licensee fails to use the Facility during the Term,

4. INDEMNITY AND WAIVER

4.1 All property of whatever nature or kind brought to the Facility by the Licensee during the Term shall be brought on to the Facility at the sole risk of the Licensee.

4.2 The City makes no representation or warranty to the Licensee concerning liability for loss or damage to such property while at the Facility.

4.3 The Licensee covenants and agrees that it shall not make or bring any claim, action, suit, proceeding or demand against the Facility Owner, the City, their elected officials, officers, employees, servants, agents and contractors with respect to any suit, proceeding, claim or demand made or brought against the Facility Owner and or the City by any party with respect to any occurrence, incident, accident or happening relating in any manner whatsoever to the negligent acts or omissions of the Licensee, its employees, agents and invitees, and which indemnity shall, without restricting the generality of the foregoing, include all legal costs on a solicitor and client basis incurred by the Facility Owner and or the City in defending such a claim, action, suit, proceeding or demand.

5. INSURANCE

5.1 It is recommended that the Licensee, at its own expense, obtain and maintain throughout the Term, General Liability insurance in an amount not less than two million dollars (██████████) per occurrence for death, bodily injury, property damage, and personal injury. This insurance policy should be endorsed to add the City of Edmonton and Facility Owner as an additional insured and include the following coverage's:

- (a) Blanket contractual,

6.1 The final authority on all matters at the Facility shall be the Facility operator.

7. GENERAL

7.1 Any disputes regarding any matter concerning the use of the Facility by the Licensee, pursuant to the terms of this License, shall be referred to the City's Director of Access to Recreation and Sport, Community Services Department. The final decision on all matters related to this License shall rest with the Facility owner.

7.2 This License shall not be assigned or transferred without prior written consent of the City.

7.3 The personal information collected in this License is collected under the authority of S.33(c) of the Freedom of Information and Protection of Privacy Act and will be used to administer program registrations, membership management and facility bookings for the City. 7.6 The waiver by the City or the Licensee of the strict performance of any term or condition in this agreement shall not constitute a waiver of any other term or condition nor shall it be deemed a waiver of any subsequent breach of the same or any other term or condition in this License.

7.7 This License shall not be modified, varied or amended except by the written agreement of the City and the Licensee.

Schedule C: School Gymnasiums**1) CANCELLATIONS:**

If a User Group cancels their booking date, the following shall apply:

- a. A User Group may terminate or reduce the Term of the License Agreement by providing the City written notice at least sixteen (16) days in advance of the date for termination, or reduction of the Term. The User Group shall receive a full or pro-rated refund of any fee paid for the part of the Term.

- Upon arriving at the facility, the supervisor of the User Group must identify themselves to the facility staff on duty, supervise the entry and exit of their participants, and provide a copy of the Booking Agreement (electronic or physical).
- Inspect the facility, change area, and washroom facilities for damage and safety hazards. NOTE: Any damage and/or safety issues must be reported to the facility staff on site or your User Group will be assessed repair costs. If the booking slot is divided for use by distinct User Groups/teams of the same organization, the subsequent supervisors will repeat the inspection.
- The User Group supervisor is responsible for the conduct of the members of the User Group they are supervising; as such, they are responsible to enforce all rules of the Facility and any instructions from Facility staff. Failure to do so will result in the immediate cancellation of your booking.
- All participants are expected to be respectful of the facility and staff.
- Supervise entrances and adjacent areas to prevent unauthorized persons from entering the building.
- Limit activities to the area assigned to the User Group and restrict participants to these areas.
- Ensure street shoes are not permitted in gymnasiums and that participant's footwear is clean, non-marking and soft soled. (Note: all dance groups must wear soft soled shoes)
- All participants must use approved indoor equipment for their activity.

7) In the event of damage, the User Group responsible will be required to pay the cost of repairs within thirty (30) days of receipt of an invoice (normal wear and tear is accepted by the Facility). Failure to do so will result in the immediate cancellation of the booking. The User Group will be invoiced for repairs.
