1.1 The City shall provide a monthly invoice that describes the Facility use by the Licensee and the amount owing, if any, to the City by the Licensee. The Licensee shall pay the City in a manner consistent with the instructions indicated on the invoice.

2.2 The Licensee will not do or permit to be done in the Facility anything which may render void or voidable any insurance policy or policies.

2.3 Unless otherwise specifically authorized in writing by the City, the Licensee is prohibited from conducting the following activities: a) possession or sale of alcohol; b) the sale of merchandise, souvenirs or novelties; c) rentals of any kind; d) any advertising; and e) any commercial filming, photography or media coverage;

2.4 The Licensee shall comply with the Facility Regulations attached as Schedule "C". The City may amend the Facility Regulations from time to time, and in the event that the Facility Regulations are found to be inconsistent, contrary to, or in conflict with the wording of the License Terms and Conditions, the wording of the License Terms and Conditions shall apply.

3.1 The City may immediately terminate this License with forfeiture by the Licensee of all License Fees paid to the City if:

- a) the Licensee fails to use the Facility during the Term,
- b) the Licensee fails to comply with the provisions of this License,
- c) the Licensee fails to comply with the directions of the Facility operator.

3.2 The City may terminate this License or amend the Term, with the License Fee to be adjusted on a pro rata basis, by providing written notice to the Licensee if:

- a) a mechanical failure occurs in the Facility or its related equipment;
- b) it would not be advisable, in the opinion of the City, to use or occupy the Facility; or
- c) the City provides notice more than five (5) days in advance of the date of termination or amendment.

3.3 The City may change the Facility from one location to another by providing written notice to the Licensee of such change.

4. INDEMNITY AND WAIVER

4.1 All property of whatever nature or kind brought to the Facility by the Licensee during the Term shall be brought on to the Facility at the sole risk of the Licensee.

4.2 The City makes no representation or warranty to the Licensee concerning liability for loss or damage to such property while at the Facility.

4.3 The Licensee covenants and agrees that it shall not make or bring any claim, action, suit, proceeding or demand against the Facility Owner, the City, their elected officials, officers, employees, servants, agents and contractors with respect to any suit, proceeding, claim or demand made or brought against the Facility Owner and or the City by any party with respect to any occurrence, incident, accident or happening relating in any manner whatsoever to the negligent acts or omissions of the Licensee, its employees, agents and invitees, and which indemnity shall, without restricting the generality of the foregoing, include all legal costs on a solicitor and client basis incurred by the Facility Owner and or the City in defending such a claim, action, suit, proceeding or demand.

5. INSURANCE

5.1 It is recommended that the Licensee, at its own expense, obtain and maintain throughout the Term, General Liability insurance in an amount not less than two million dollars [REDACTED] per occurrence for death, bodily injury, property damage, and personal injury. This insurance policy should be endorsed to add the City of Edmonton and Facility Owner as an additional insured and include the following coverage's:

- (a) Blanket contractual,
- (b) Tenant's legal liability,
- (c) Premises and operations,
- (d) Cross liability/severability of interests,
- (e) Injury to participants, if applicable,
- (f) Host liquor liability, if applicable, and
- (g) Intentional injury, if applicable

5.2 The Licensee shall, upon request by the City, provide the City with proof of the existence of such insurance in the form of a City certificate of insurance or such other form acceptable to the Facility Owner and of the City's Director of Risk Management.

6. CONTROL OF PREMISES

6.1 The final authority on all matters at the Facility shall be the Facility operator.

7. GENERAL

7.1 Any disputes regarding any matter concerning the use of the Facility by the Licensee, pursuant to the terms of this License, shall be referred to the City's Director of Access to Recreation and Sport, Community Services Department. The final decision on all matters related to this License shall rest with the Facility owner.

7.2 This License shall not be assigned or transferred without prior written consent of the City.

7.3 The personal information collected in this License is collected under the authority of S.33(c) of the Freedom of Information and Protection of Privacy Act and will be used to administer program registrations, membership management and facility bookings for the City. Aggregate data will be used for program planning and evaluation. Questions about the collection of personal information should be directed to the Community Services FOIP Coordinator at 496-4999. 7.4 The Laws of the Province of Alberta shall govern this License.

7.5 This License is the entire agreement between the City and the Licensee with regard to the matters dealt with in it, and there are no understandings or agreements, representations, warranties, conditions or collateral terms, verbal or otherwise, existing between the City and the Licensee except as expressly stated in this License or as agreed in writing by the parties.

7.6 The waiver by the City or the Licensee of the strict performance of any term or condition in this agreement shall not

constitute a waiver of any other term or condition nor shall it be deemed a waiver of any subsequent breach of the same or any other term or condition in this License.

7.7 This License shall not be modified, varied or amended except by the written agreement of the City and the Licensee.

7.8 Notices or other correspondence shall be addressed to City or the Licensee at the addresses stated on the first page of this License.

Section C:

School Gyms:

All gymnasium bookings in school facilities must adhere to the following rules to ensure compliance with the current public health orders:

A designate from your organization must verify the vaccination status of all participants - that all participants (including, coaches, volunteers and any other on-site helpers aged 12 and older) have provided the designate with either (1) proof of vaccinations; (2) a recent negative Covid test within the past 72 hours; or (3) a medical exemption. Thus, all participants are required to carry their proof of compliance (ie: vaccination and government issued identification, or negative COVID test to all bookings).

The form must be submitted to the City of Edmonton prior to the start of that day's booking. It is not the role of the custodian to review compliance of the Group Vaccination Disclosure form.

In addition, please take note of the following for community rentals accessing school gymnasiums:

Site audits will be carried out to ensure compliance of the Group Vaccination Disclosure form. Any non-compliance where a group is found to be either not completing the Group Vaccination Disclosure form prior to entry or do not have proof of vaccination status during a site audit, will be handled as follows:

1st Offence: the specific group or team will lose their next booking

2nd Offence: the specific group or team will have their remaining bookings suspended for the remainder of the season

All participants (including coaches and volunteers) must carry proof of vaccination with them while on-site in the event of a site audit.

It is not the role of the custodian to ensure compliance of the Group Vaccination Disclosure form.

No access to change rooms - participants are to arrive ready to play.

A minimum number of designated washrooms will be made available for participants.

Participants are to arrive just prior to their booking commencing and are to leave following the completion of their activity.

Participants are to be masked at all times except when they are engaging in their activity.

No spectators at this time. Pick-up and drop-off must be arranged for outside the school. User group leaders must help coordinate for younger participants.

Organizations should still be asking participants to pre-screen and communicating to them that they should not attend if they are experiencing any Covid-19 symptoms.

Changes to bookings and/or procedures may change with modification to public health orders.

1) CANCELLATIONS:

If a group cancels their booking date, the following shall apply:

a. A group may terminate or reduce the Term of the License Agreement by providing the City written notice at least sixteen (16) days in advance of the date for termination, or reduction of the Term. The group shall receive a full or pro-rated refund of any fee paid for the part of the Term.

b. If the group fails to provide the City with written notice at least sixteen (16) days in advance of the date of termination or reduction of the Term, the Booking Fee paid/due will be non-refundable.

c. If no members of the group attend the booking, the rental booking will be considered a "no show" for which the rental booking fee will still apply. All "no show" and rental booking fees must be paid in full.

d. Consideration will be given to cancellations due to inclement weather (i.e. severe snow storms) provided that the group notifies the booking agent by 12:00 noon of the day of the booking.

2) Facility doors shall be open ten (10) minutes before and re-locked ten (10) minutes after the commencement time on the license agreement. Should the group fail to report during this time, the date will be considered a "no show" on the license.

3) All groups shall vacate the booked space no later than the end on their license agreement and vacate the facility no later than (10) minutes after the end time on the license agreement.

4) No food or drink is permitted during activities without special permits. Schools and School property are no smoking areas.

5) User groups are responsible to provide and maintain their own first-aid kit. They are also responsible to have a person

available with first aid training that can administer first aid to their participants and arrange for transportation for medical treatment if necessary. An automated external defibrillator (AED) is available at select school locations but the facility owner will not provide a trained technician. Supervisors for user groups may contact the school principal (in Edmonton Catholic Schools) or custodian (in Edmonton Public Schools) to familiarize themselves with the location of the AED (where available) and for access to the equipment if it is required.

- 6) Supervisor of the rental group duties and responsibilities:
- a. Upon arriving at the facility, the supervisor of the rental group must identify themselves to the facility staff on duty.
 - b. Inspect the rental facility, change area, and washroom facilities for damage and safety hazards. NOTE: Any damage and/or safety issues must be reported to the facility staff on site or your group will be assessed repair costs. If the booking slot is divided for use by distinct groups/teams of the same organization, the subsequent supervisors will repeat the inspection.
