IMPORTANT NOTES ABOUT THE LEAGUE:

- We're now about halfway through the season! ESSC encourages all teams to check their standings to ensure the information is accurate.

ESSC UPDATES:

- Fall 2026 League Registration is **NOW OPEN**
 - **August 12** - Early Bird Deadline is in **13 DAYS**
 - Register a full team by the Early Bird deadline to be automatically entered to win: 1 free team registration, 1 of 5 \$100 Club credits, 1 of 5 \$50 Sponsor Bar gift cards, or 1 x \$350 Ticketmaster gift card
- **August 15 & 16** - Slo-Pitch Tournament
- **August 22** - Beach Volleyball Tournament

- **Please remember the following rules at the Pickleball Hub:**
 - Do not enter the facility prior to 15 minutes ahead of scheduled start time.
 - Do not enter the gym space before the EC arrives.
 - Do not use any Pickleball Hub equipment.
 - Do not use any of the courts before scheduled start time.
 - Match-ups listed top to bottom on the schedule correspond with which court each team is playing on.

DEFAULTS

- *Ensure all teams have enough players to avoid defaults (1 total player, no gender requirements, is the minimum at start time). If this requirement isn't met, this team will automatically lose the first game 0-11 and then has 15 minutes to meet these requirements or they will lose the second game 0-11 and effectively the entire match. This process would repeat as soon as the second match starts. Fee is \$30/match. The Default Score includes the third game: 0-11; 0-11; 0-11.*

START GAMES

- *Announce who is playing who on which court (see Court Allocation notes below). Repeat for Match 2.*

GAME FORMAT

- *Matches are mandatory 3 games: non-rally point to 11 for all games.*
- *Games must be won by 2 points but capped at 15.*
- *A third game cannot be started if there is less than 5 minutes remaining in the match.*
- *Rock, Paper, Scissors for serve in the first and third games. The opposite team serves first in game 2.*

 - o Court 3, then Court 6, then Court 7, then Court 8
- Schedules have been built so that each team has about an even number of times on the less-than-ideal courts.
